Dr. G. Saravanan, State government nominee appreciated the overall performance in the academics, research, student performance and placement. In addition he insisted to have awards for best paper presenter in the conference and to motivate the participants.

Dr. K.Rukmani, Anna university nominee, appreciated the institute for various achievements and student admission. She highlighted various points such as:

- To apply for the conference funding from AICTE on Emerging Technology.
- Insisted on the Outcome of the alumni event.
- Regulation of the institution should match with Anna university Regulation 2023 for deliberation of Recent developments.
- Credits should be allocated for AICTE Smart India Hackathon participants in order to motivate them. 1 credit for participating, 2 credits for qualifying for final presentation and winning. Autonomy should be given for the students to create an innovative idea and develop them into products or projects from the first year onwards due to which they can earn the external exposure.
- Recruitment process to be improved by recruiting industrial experts and should avoid taking in breeding. Preference can be given for qualified candidates from premier institute. During recruitment assessment 50% may be subject knowledge and rest 50% should include teaching learning methodology (i.e.) latest technology up gradation, coding and its demo, certification of latest technology etc.
- Industrial expert may be invited for sharing their hands on experience and they should be both trainers and developers. If possible for certain topics students can be taken to industry for real time exposure.
- Should encourage staff and students to participate in conference, workshops and seminars in other states, and even if it is possible to attend other continents too. DC members can be from the other state to contribute their expertise.
- Specific points to be highlighted for the non-statutory committee's contribution.
- Few more discussions were done on the vision and mission alignment with NIRF, Review of publication, Vidwan portal registration, industrial collaboration, Registration of NPTEL 8 Modules courses by staff members.

Dr. Lavanam Ambala, industrial expert nominee appreciated the performance and progress in academics and the remarkable infrastructure of the institution. He also acknowledged the

chairman for taking new initiatives in academics and placement. In addition he suggested various points such as

- Should encourage students and faculty members to carry out interdisciplinary paper presentation and publication.
- Recruitment of qualified candidates from premier institute to be done and while recruitment assessment 50% may be subject knowledge and rest 50% should include teaching learning methodology (i.e.) latest technology up gradation, coding and its demo, certification of latest technology etc.
- Insisted to frame a roadmap for the strategy - what to be achieved, how to achieve and what resources required to achieve.

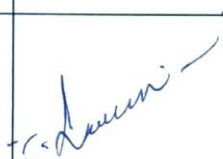
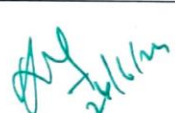

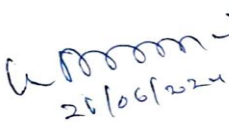
